36-03-2013 Nature Preserve Committee Request

Moved by councillor Mr. David Prentice that the Municipality of Sheenboro support the purpose of the above-noted Committee which aims to create hiking trails in the Sheenboro Nature Preserve managed by the Nature Conservancy of Canada (NCC). A previous council approved the creation of a nature preserve there with hiking trails.

As the NCC has by way of a letter dated February 15th 2013 declined the Committee's proposal for the creation of new trails, the Municipal Council want to support the Committee in their request of the NCC to reconsider its decision and approve the proposal and work with the Committee to see that all interests are met, namely, the community's need for a nature preserve on the Ottawa River in the Upper Pontiac while ensuring the conservation of the property's resources (flora and fauna) are protected. On approval, the Municipal Council will support the Nature Preserve Steering Committee in its mission to share the property with the public by creating hiking trails and interpretative panels in an ecologically sensitive manner that meets the NCC's management plan directives. This 500 acres of land has but one access road and access by river, most of the property is inaccessible to observe birds, flora and fauna or for nature walks.

Many people are proud of the logging history since most families worked in this field for centuries now they would like to visit this property.

Note that the Oiseau Rock Hiking Trail requires a drive through the Zec gate, approximately 8 km from Sheenboro, and hikers are charged a fee to hike the trail. Many hikers do not go there during hunting season or in the winter due to the road conditions.
