5. Foreman report

Mr. Waddington mentions that the roads were graded; Trout Lake road has been graded and pot holes fixed with gravel; ditches were fixed on Sarah and Mountain roads; cold patch was done on Sheen and Fort-William roads; sweeping was done and they did a good job; the hill on Tripp road should be fixed and the shoulder is too soft closed to Mark Jennings property; culvert on ICO needs to be unblocked; culvert should be changed on Sullivan road this week; work has been done in the park to fix the bench, picnic table and horseshoe pit.

6. Questions from the public and visitors

Pro-mayor Mr. Dick Edwards is chairing the meeting.

Hudson Bay road residents

Mr. Robert Brunette is representing 12 taxpayers. He is making a request for a take over by the municipality of the private section of Hudson Bay road and Ferguson Bay road. According to them, the municipality should take it over because the roads are colonisation roads. He mentions that this request was previously made by Mr. Carroll in 2014 and the response has been to bring the roads up to standards. He has some quotations from contractors mentioning that 3 sections need to be bring up to standards. The cost per each section could be: # 1. \$ 36 000.00; #2. \$ 7 500.00; #3. A couple of thousand dollars. Mr. Nicolas Thomson mentions that they are having problem with the school bus; the bus is not pick-up their child at their home on Ferguson Bay road. Mrs. Karen Keon mentions that the road was maintained; it was plowed and calcium was applied. Mr. Dave Croft would like to know if he is located on the municipal or the private section of Hudson Bay road.

Answer: Council will examine the request. No money was planned in the budget for this project.

Mayor Mrs. Doris Ranger is chairing the meeting.

Mr. Neil Meehan

Mr. Meehan asks for the removal of the stones left on his property when the work was done on Fort-William road.

Answer: Director General did a lot of calls and send Emails to the engineer and the Fleming. The Fleming were supposed to removed the stones last fall according to Jean-Pierre Ledoux that did the follow-up for WSP. They didn't. Director General tried to get in touch with WSP on this issue but nobody is answering her requests. She is still trying.

Mr. Joe Selkirk

Mr. Selkirk wants to know what the municipality will do about the flood wastes.

Answer: The item is on the agenda.

Mrs. Denise Roberge

Mrs. Denise Roberge wants to know what the municipality will do for the flood problems on the roads. She is mentioning ICO and Tripp hill.

Answer: Director General had the MRC engineer looking at the problems on several roads. The engineer will send some recommendations.

Mr. Shamus Morris

Mr. Morris is having a problem with a beaver dam close to Mrs. Marilyn Crozon and wants to know about the Town Line road. Mrs. Marilyn Crozon could be land locked.

Answer: The Town Line was a colonisation road. Parts were in Sheenboro and Chichester. The municipality was not maintaining this road. The land set aside shall revert by law to the land from which it was detached and shall be the responsibility of the owner of that land. Mr. Morris is invited to contact the surveyors in charge of the cadastre renovation to get more information. For the right of way for the owner of land enclosed, the Civil Code mentions that this matter should be addressed by the owners themselves.
