Response: Sheen road is on the list of roads for repair this year.

3- Why is 1 KM of Perrault road planned to be repaired in 2021 when it has been 3 years that residents are requesting road work on Sheen road?

Response: The road work for the gas tax money was planned and prioritized last year by council, and Sheen road does have work planned in 2021 to fix the big rocks that are popping up.
