B. Benefits Resolution

- Subscription to the group insurance program of the Quebec Federation of Municipalities
- WHEREAS the Quebec Federation of Municipalities (hereinafter the FQM) has set up a group insurance program governed by one of its regulations (the Program);
- WHEREAS to this end, the FQM proceeded with a call for tenders bearing number FQM-2021-002 dated July 5, 2021;
- WHEREAS to follow up on its call for tenders' process, the FQM has become the Policyholder of a group insurance contract with Desjardins Financial Security, life insurance company (hereinafter the Contract);
- WHEREAS the FQM has mandated its subsidiary FQM Assurances Inc., broker in group insurance, the mandate to ensure the application of the Contract and to advise the municipalities, their officials and employees and the members of the municipal councils with regard to all questions or a permit broker is required under the Act respecting the distribution of financial products and services, c D-9.2;
- WHEREAS under the Municipal Code of Quebec and the Cities and Towns Act, a municipality, an MRC or a municipal body may adhere, for the benefit of its officials and employees and members of its council, to an insurance contract collective whose Lessee is the FQM;

WHEREAS the Contract entered into force on January 1, 2022;

WHEREAS the Contract is automatically renewable every year:

- THAT the Municipality (or MRC or organization) adheres for the benefits of its officials and employees and members of the municipal council to the Program and is governed by the Contract dated August 8, 2022;
- THAT the Municipality (or MRC or organization) pays the premiums relating to the year of coverage as well as all premiums and premium adjustments for each subsequent year;
- THAT the Municipality (or MRC or organization) respects the terms and conditions of the Program and the Contract;
- THAT the Municipality (or MRC or organization) maintain its participation in the Program by subscribing, without additional formalities, to any group insurance contract concluded by the FQM to respond to a call for tenders to replace the Contract and by respecting the terms and conditions;
- THAT the Municipality maintain the insurance coverage provided for in the Contract or in any contract replacing it, and this, until the Municipality terminates, in accordance with the regulations, its participation by transmitting the FQM a written notice of at least one (1) year mentioning its intention to no longer participate in the program;

THAT the Municipality (or MRC or body) empowers its Director General to perform any act and transmit any document resulting from the Municipality's adherence to the Contract or any contract replacing it;

THAT the Municipality (or MRC or organization) authorizes FQM Assurance and any firm of consulting actuaries designated by the latter, to have to its group insurance file with the insurer in compliance with the rules for the protection of personal information;

THAT the Municipality (or MRC or organization) grant FQM Assurance Inc. and any firm of consulting actuaries designated by the latter, the mandate to as expert advisor and exclusive broker in group insurance and that they be the only persons appointed and authorized to represent it with the insurer with respect to the application of the group insurance plan;

THAT this resolution in no way limits the right of the FQM to revoke its representatives and substitute another;

THAT this resolution is immediate and revokes any other resolution previously granted on the same subject as this resolution, without further notice.

C. Resolution for PRABAM Extension

- WHEREAS in March 2021, the Government of Quebec presented the Action Plan for the construction sector which aims to take full advantage of the Plan Québécois d'infrastructures and to revive the economy in the context of the pandemic;
- WHEREAS one of the measures of this plan consists in setting up a program with an envelope of \$90 million aimed at granting financial assistance to municipalities of 5,000 inhabitants or less to allow them to quickly carry out work in their municipal buildings;
- WHEREAS the work must be carried out between June 1, 2021 and May 31, 2023;
- WHEREAS some municipalities of the MRC Pontiac wish to take advantage of this program, but are faced with a shortage of labor when they have to use the services of an architectural or engineering firm;
- WHEREAS the deadlines requested by the firms of architects or engineers to deliver the work greatly exceed the deadlines required by the municipalities to hold a tendering process, approval by the Council and the completion of the work;
